VII. Detailed Terms and Conditions of Dr. Shivlal Goyal Scholarship

1. Scholarship Overview:

- The Dr. Shivlal Goyal Scholarship is generously sponsored by Dr. Shivlal Goyal, Chairman and Managing Director, Kutch Chemical Industries Limited.
- The fixed scholarship amount is Rs. 25,000/- (Rupees Twenty-Five Thousand Only) per student per year.

2. Eligibility Criteria for Grant:

- **Academic Performance:** The applicant must have secured a minimum of 70% marks or equivalent CGPA in their previous qualifying examination (10th or 10+2 or Diploma from recognized boards). This achievement must be in the first attempt, with all subjects successfully passed.
- **Annual Income:** The total annual income of the applicant's parents/guardians from all sources must not exceed Rs. 3,00,000/- (Rupees Three Lakhs Only).
- **Financial Grants:** The scholarship will not be admissible to any student who has already been granted any other scholarship by ITM Vocational University or is receiving any other grants, concessions, stipends, or any form of financial support from other external sources/organizations.
- **Documents:** All supporting documents as asked must be provided at the time of application.

3. Application Process:

- Candidates are required to apply by downloading the application form, which is available on the university website or by submitting an offline application form obtained from the campus. The application must be submitted within the specific timeline notified through the University's Admission Notification.
- Applications must be submitted in hard copy with all required documents to the office of the registrar, and also need to share the scanned copy of the same to registrar.office@itmvu.in
- It is solely the responsibility of the candidate to ensure that all required documents are submitted along with the application. Any application found to be incomplete will be summarily rejected without further consideration.
- If the number of eligible applicants exceeds the number of scholarships available, the final selection will be based on merit.

4. Scholarship Continuation (for subsequent years):

At the end of each academic year, a student may continue to be eligible for the scholarship upon strict fulfilment of criteria based on Academic Performance, Academic Integrity, Code of Conduct, Attendance and any other with reapplication.

5. Scholarship Withdrawal:

The scholarship shall be withdrawn at any time during the academic year, from the date as approved by the competent Authority, under the following conditions and the student will be liable to pay the equivalent amount and with relevant action:

- During the tenure of the scholarship, if the Head of the Institution/Department reports that the student has been charged with misconduct, misbehaviour, gross indiscipline, an incident of ragging, etc., the scholarship will be revoked.
- If documents or annual income data provided by the student are found to be false or fraudulent at any point in time during or post the admission.
- The student has been granted any other scholarship by the University or any outside organization.
- In case after awarding the scholarship, the student withdraws the admission or later discontinues the study, the scholarship would be revoked, and it would be awarded to another deserving student.
- In the event of any discrepancy or violation of Scholarship terms, the scholarship for the specific student will be revoked.

6. Disbursement of Scholarship:

The amount of Scholarship during the academic year will be Rs. 25,000/- (Rupees Twenty-Five Thousand Only). The Scholarship amount will be disbursed directly to the ITM Vocational University and not to the candidate's account.
